

SANFORD-FRITCH INDEPENDENT SCHOOL DISTRICT

A RESOLUTION BY THE SANFORD-FRITCH INDEPENDENT SCHOOL DISTRICT AUTHORIZING AN AGREEMENT WITH THE CITY OF FRITCH AND THE CITY OF SANFORD TO CONDUCT A JOINT ELECTION.

WHEREAS, §271.002(a) of the Texas Election Code states that a city is authorized to hold an election jointly with the elections of one or more other political subdivisions if the election of the city and the elections of one or more other political subdivision are to be held on the same day in all or part of the same territory, and the governing bodies of the city and one or more other political subdivisions enter into an agreement to hold the elections jointly in the election precincts that can be served by common polling places; and


WHEREAS, the Sanford-Fritch Independent School District Board of Trustees has ordered that an election be held on May 1, 2021 for the election of two trustees and the City of Fritch and the City of Sanford has ordered that an election be held on that same day, and


WHEREAS, it would be advantageous to both entities to hold a joint election that can be served by common polling place;


NOW THEREFORE, be it resolved by the Sanford-Fritch Independent School District Board of Trustees that; The Board President and the Superintendent are authorized to enter into an agreement with the City of Fritch and the City of Sanford to hold a joint election in accordance with §271.002, of the Texas Election Code. A copy of the joint election agreement to be entered into is attached hereto as Exhibit A, and is incorporated herein as if fully set forth.
