

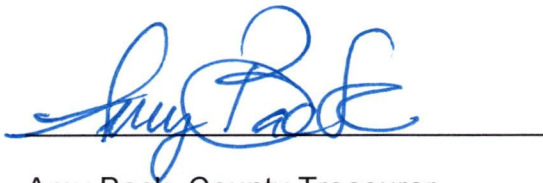
TREASURER'S CERTIFICATE
